Governance Board - An overview

The GB is a formal working-group of the H2020 Strategic Configuration of the Programme Committee, running until the end of 2020.

Representatives from the Member States, Associated Countries, and the Commission to ensure effective supervision of EOSC implementation.







Governance Board - Mandate

 Deciding the strategic orientations for the EOSC and approving an annual work plan.

- Post-2020 planning.
- Endorse the mandate of EOSC WGs.
- Assessing the progress of the EOSC implementation.
- Ensuring coordination with relevant Member States/Commission initiatives.
- Approving new activities in support of the EOSC, including its long-term sustainability.





Governance Board - Membership

Membership:

 All 28 member states plus 10 associated countries: Albania, Iceland, Israel, Moldova, Montenegro, Norway, Serbia, Switzerland, Tunisia, Ukraine. See: https://ec.europa.eu/research/openscience/pdf/ecrtd-eosc-governance-board-082019.pdf

EOSC is a co-construction:

- Providing inputs and feedback from the stakeholders and communities in participating countries.
- Ongoing dialogue and clear communication channels to keep the work of GB in touch with what is going on on the ground in each country

Governance Board - Subgroups

Support the work of the GB by providing analyses and recommendations on key issues relevant to EOSC development and sustainability.

Three subgroups established initially:

- **Compatibility** of EOSC with current/planned national structures/initiatives.
- Regulatory framework for the emerging ecosystem.
- Data: Underpinning the resilience of the EOSC.

Will work closely with the relevant EB Working Groups and may:

- Provide questions, specific issues, and feedback to related WGs.
- Participate in (selected) meetings of related WGs.
- Suggest the inclusion of experts.
- Monitor outputs and report findings as a basis for in-depth discussion in GB.





GB SG 1: Compatibility of EOSC with current/planned national structures/initiatives

Objective:

- Analyse compatibility of national plans for data infrastructures and Open Science with EOSC developments and vice versa.
- Explore possible models for a partnership based on a first insight into the outline of the national landscapes and preferences and possible contributions of different countries.

EB WGs interaction:

- Landscape.
- Sustainability.

First exercise:

 Draft some basic outlines for a possible model on a European partnership.





GB SG 1: Compatibility of EOSC with current/planned national structures/initiatives

Members:

Subgroup of around 11 member states.

Actions:

- Questionnaire on characteristics of the national landscape and possible features for a European partnership.
- Preliminary evaluation and summary, to be discussed in GB meeting of 11 September 2019.





GB SG 2: Regulatory framework for the emerging ecosystem

Objective:

 The implementation of EOSC in different national contexts will be challenging with respect to regulation, research funding rules, legal aspects, and business models.

EB WGs interaction – cover SG2 topics in complementary ways:

- Sustainability.
- Rules of Participation.

Members:

Subgroup of 7 member states.





GB SG 2: Regulatory framework for the emerging ecosystem

Actions:

- Series of calls between GB delegates and EB WG leads.
- Minutes shared in: https://repository.eoscsecretariat.eu.

Preliminary list of questions/ strategic issues being compiled:

- What kind of light regulatory environment is needed?
 Aim to harmonise differences across the EU and ensure a level playing field that will genuinely boost European research and innovation.
- Questions of IPR and data sovereignty.
- How to ensure sustainable cost models?





Governance Tasks in 1st Stage of EOSC




- 1st stage of EOSC: 2018-2020
- H2020 projects: c. €600 million
- Address six roadmap action lines:
 - ♦ data ♦ services ♦ architecture
 - ◆ access ◆ rules ◆ governance
- Steer initial implementation
- Involve all R&I stakeholders
- Transition to 2nd of stage: 2020+
